
# TRANSPORTATION DEVELOPMENT CREDITS (TDCs) REVOLVER FUND: 100 MILLION CREDITS FOR \$10 MILLION

### BACKGROUND

- Transportation Development Credits = TDCs
- TDCs are "earned" by the region when toll revenues are used to fund capital projects on public highways
- 465 million credits available in the DFW region
- TDCs are not money or cash
- They do not increase funding for a given project
- Eligible "match" to federal funding award

## CATEGORY 4: SELL TDCs TO TxDOT AND OTHER MPOs

- Previously, the RTC approved staff to negotiate a transfer of up to 150 million in TDCs to other MPOs (50 million) and/or TxDOT (100 million), contingent on RTC approval of the final transfer.
- Staff has been working with TxDOT on a transfer partnership since early 2014.
- In June 2014, TxDOT approved a transfer of 100 million credits for \$10 million to create an MPO Revolver Fund.

# CATEGORY 4: SELL TDCs TO TxDOT AND OTHER MPOs (cont'd)

- In July 2014, the RTC was briefed on this proposed partnership.
- Initial conversations with TxDOT indicate that the transfer will likely occur through a funding exchange on a TxDOT project, thereby releasing State/local funds for the MPO Revolver Fund.
- The MPO Revolver Fund would be used to provide cash flow to regional programs and projects implemented by NCTCOG that are funded with federal dollars.

## **ACTION REQUESTED**

#### Recommend approval of:

- Transferring 100 million TDCs in exchange for a \$10 million MPO Revolver Fund.
- Creating the MPO Revolver Fund to be used to cash flow federally funded regional programs and projects implemented by NCTCOG.
- Returning to TDC pool for future reallocation:
  - Balance of 33.24 million TDCs under Category 3 (Type 2 Call

     Local Agency Has Revenue) and
  - Fifty (50) million TDCs under Category 4 (Sell TDCs to MPOs and TxDOT)
- Administratively amending the Transportation Improvement Program (TIP)/Statewide TIP and other necessary administrative documents.
