



SolSmart: Helping North Central Texas Earn Recognition as a "Solar Friendly" Region

North Texas Ozone Season Underway

The ozone season began in North Texas on March 1 and will last through the end of November. The height of ozone season typically begins in May when temperatures begin rising, but now is a good time for North Texans to begin considering how their actions could improve the air during ozone season, which has been extended by one month.

With the Environmental Protection Agency recently lowering the ozone standard from 75 parts per billion (ppb) to 70 ppb, the region will need to continue to work together to improve air quality. The 2016 design value for the North Texas region was 80 ppb, with seven counties in nonattainment for the 70 ppb standard. The EPA anticipates announcing the nonattainment designations for the 70 ppb standard in October. For current information on the region's ozone levels, visit www.nctcog.org/ozone.

The North Central Texas Council of Governments maintains many policies and programs intended to help residents and businesses participate in clean air efforts. One is Air North Texas, which provides individuals, local governments and businesses lists of strategies they can implement when air quality is forecast to be poor.

Air North Texas implements a regional clean air event, Clean Air Action Day, on the first Friday of each summer. Clean Air Action Day 2017 will fall on June 23, and participants are asked to implement a clean air action that will help reduce ozone in the region. Defend Your Drains – Medicine Take-Back Event April 29, 2017

When medicines (antibiotics, vitamins, cough syrup, pain medicines, etc.) are put down the drain or into the toilet, they end up polluting the water supply because water treatment processes can't completely remove them. So, instead of flushing medications, check our locator map to find a take-back location near you to dispose of them properly. Additionally, the Drug Enforcement Agency sponsors take-back events twice per year, with the next one taking place on April 29, 2017 from 10:00 a.m. until 2:00 p.m. Check with your city to find more information about locations near you to dispose of medication on April 29. 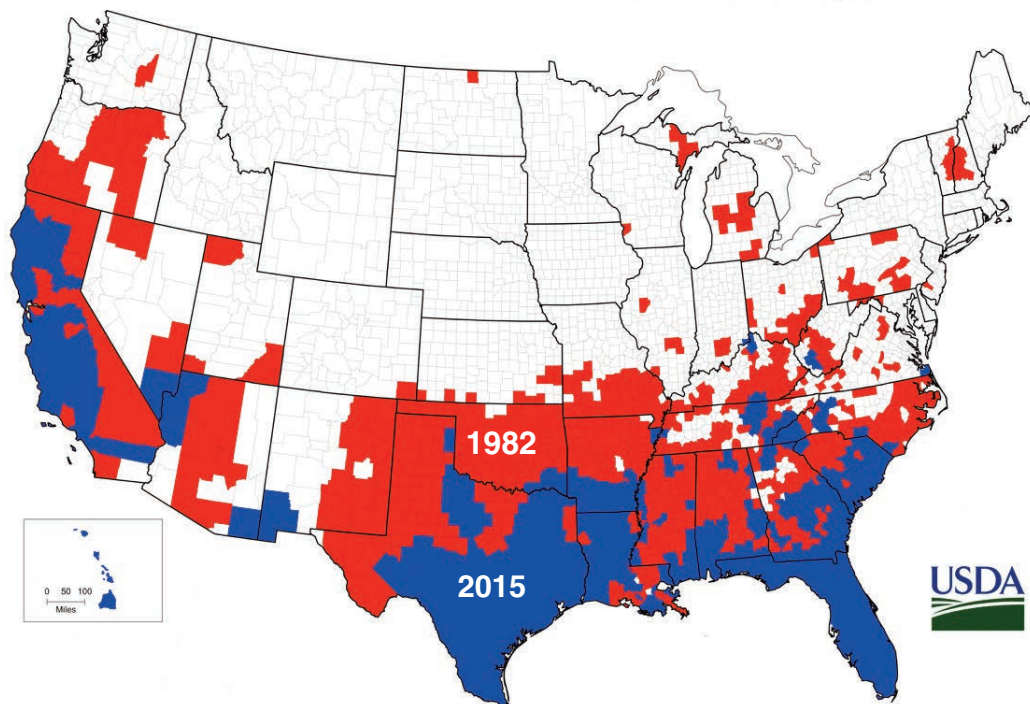

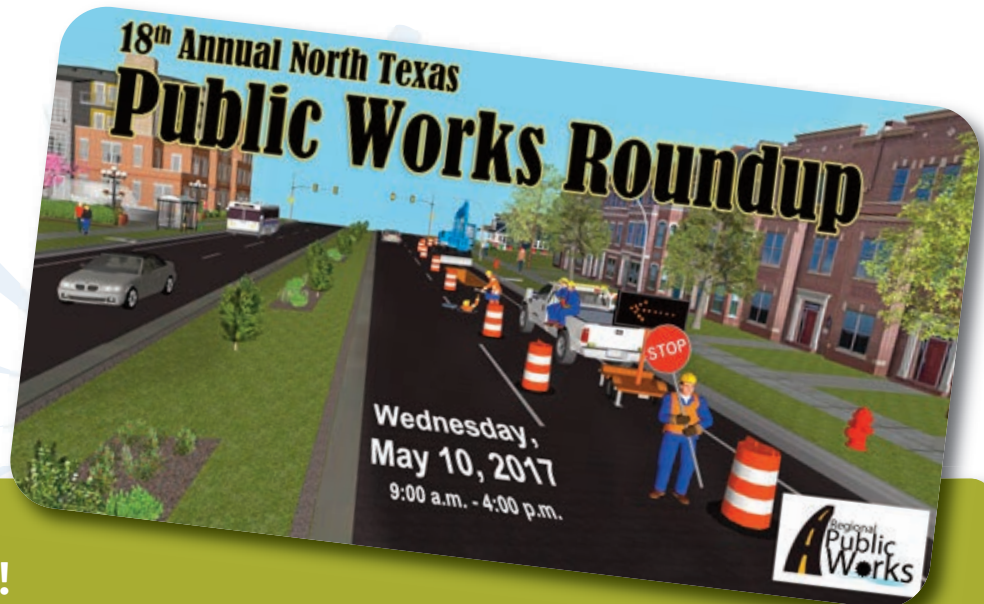

Trash dumped in unauthorized locations is not just appalling, it can cause major public health and safety concerns such as an increase in rodents and mosquitoes, related illnesses, and physical and chemical hazards like protruding nails and harmful fluids. Dumping is also illegal and punishable by the **Texas Health and Safety Code 365**.

ReportDFWdumping.com is a website designed for easy access to illegal dumping reporting and solid waste programs available in the North Central Texas region. The goal of this web site is to increase awareness of the hazards of illegally dumping trash and to encourage all citizens in the region to participate in local recycling and solid waste programs.

As mandated by the U.S. Constitution, each decade America counts its population. The data collected by the decennial census determine the number of seats each state has in the U.S. House of Representatives and are used to distribute billions in federal funds to local communities.

The next Census in 2020 will require counting an increasingly diverse and growing population of around 330 million people in more than 140 million housing units. To get an accurate count, the Census Bureau must build an accurate address list of every housing unit, maximize self-response to the census, and efficiently follow up with those who do not respond.

The decennial census is the largest mobilization and operation conducted in the United States and requires years of research, planning, and development of methods and infrastructure to ensure an accurate and complete count. You are invited to attend **Road to 2020**. At this event, you can:
